Hingham Municipal Lighting Plant Energy Star Appliance Rebate Incentive

Hingham Municipal Lighting Plant is pleased to announce it will offer rebates to customers purchasing selected energy efficient **ENERGY STAR** refrigerators, clothes washers, dishwashers, unit air conditioners, central air conditioners, dehumidifiers, or programmable thermostats during this current year. **ENERGY STAR** appliances have been defined by the Department of Energy (DOE) as being significantly more energy efficient than the average comparable model.



The advantages of purchasing an **ENERGY STAR** appliance:

Potential savings in energy costs of 15 - 50%.

Reduction of global energy consumption and need for additional generation.

Decrease in pollution from fossil fuels used to generate electricity.

REBATE ELIGIBILITY REQUIREMENTS

- *Customer must have an active residential account with Hingham Municipal Lighting Plant.*
- *Customer rebate will be in the form of a check mailed to the address on the customer's account.*
- *Customer account must be in good standing with HMLP.*
- *Only selected **ENERGY STAR** appliances are eligible for rebates. Appliances that may qualify will have the **ENERGY STAR** logo on the yellow EnergyGuide label attached to the appliance.*
- *Proof of purchase in the form of a legible copy of the sales receipt showing the appliance model number and date on or after January 1, of this current year, a copy of the EnergyGuide label from the appliance purchased, and a completed Hingham Municipal Lighting Plant **ENERGY STAR** Appliance Rebate Incentive Application must be submitted in order to be eligible for a rebate. * (**NOTE: THE LAST DAY FOR RECEIPT OF THIS CURRENT YEAR APPLICATIONS/COMPLETED PAPERWORK WILL BE JANUARY OF THIS YEAR**)*
- *Purchases made on or after January 1, of this current year on qualified Energy Star appliances may be eligible for HMLP Energy Star Incentive Rebate.*
- *Energy Star rebates: Refrigerators \$75; Clothes Washers \$50; Dish Washers \$50; Unit Air Conditioners \$50; Central Air Conditioners (>14 seer) \$100; Dehumidifiers \$50; Programmable Thermostats (50% up to \$25), Freezer \$50, Electric water heater \$75.*
- *Appliance must be installed at the account location.*
- *HMLP reserves the right to inspect the installation on premises.*
- *HMLP Energy Star Appliance Rebate Incentive Program is available during this year– but is subject to availability of funding.*
